- California Governor's Office of Emergency Services designation of Agent(s) to execute on behalf of the District: District staff designated.


**Welcome our new Chief Harbor Patrol Officer Matthew Ashton** – The Harbor District is very pleased to announce the hiring of Matthew A. Ashton as Chief of the District's Harbor Patrol Department. Following a highly competitive recruitment, extensive interview process, and contract approval by the Board of Harbor Commissioners at their meeting of February 28, 2017, Matthew began in his new capacity as Chief Harbor Patrol Officer on March 1, 2017.

Matthew has worked for the Harbor District as a Harbor Patrol Officer since 2011. Prior to that, Ashton had a considerable career in the United States Coast Guard, serving as a Machinery Technician, Assistant Engineering Petty Officer and Federal Law Enforcement Boarding Officer. Ashton remains a United States Coast Guard Reserve with Coast Guard Station Channel Islands. The depth of Ashton's Port San Luis knowledge, coupled with his progressive approach to serving the public makes him an excellent fit for the Chief position.

Matthew is passionate about serving the public as the Harbor District's next Harbor Patrol Chief. 'When I was 15 or 16 the City of Costa Mesa presented me with a Meritorious Service Award for coming to the aid of my elderly neighbor who was in distress, at that point I knew I wanted to pursue a career in public service.' said Matthew Ashton.







**Salmon & Rock Cod Season Openings -** Rock Cod and Salmon season are opening on April 1 and April 2, respectively. As such, the Coastal Gateway parking will be closed to RV Camping beginning Friday, March 31, at noon. RV Camping will re-open on Monday, April 3<sup>rd</sup>, at approximately 4:00 pm.

**Economic Impact Report** – The District last completed, in 2013, an economic impact report on Commercial Fishing. This report is very useful in showing the significant economic impact the Commercial Fishing Industry has on the area. Also, the report can be used to provide information to potential grant funding agencies for grants on Port improvements that would enhance Commercial Fishing. Through a grant from the Central California Joint Cable Fisheries Liaison Committee, the District will have an updated report with work on the document expected to begin soon.

Fire Rings Are Back on Olde Port Beach - It's time once again to enjoy bonfires on the beach! The District's seasonal fire rings are back on Olde Port Beach for the 2017 season. Fire rings are available on a first-come, first-served basis and are not able to be reserved. Please use only clean firewood. No chemically treated wood, pallets or other wood with nails.
