**COMMERCIAL FISH BUYER'S LICENSE 2021**

(Valid January 1 – December 31, 2021)

1. Any commercial enterprise that purchases and transports fish off the Harford Pier for resale is required to buy a license annually (calendar year).
2. Fish buyers agree to follow District, County, State and Federal regulations, policies and laws while on District property. Failure to do so may be grounds for license cancellation. If the license is cancelled, the fish buyer may not reapply for another license for 12 months from date of cancellation.
3. Commercial fishermen may transport their own catch off the pier without having to purchase this license.
4. Commercial fishermen may sell their own catch off their boat to the ultimate consumer, so long as this does not disrupt operations of other pier lessees, licensees or harbor operations.
5. A special permit may be issued for selling fish in other areas of the Port other than the Harford Pier. A land use permit must be completed, submitted and approved by District staff before a permit is issued.
6. Commercial fish buyers are subject to the same pier parking regulations as other patrons, including the 2-hour time limit.

Please read carefully:
